Minutes of last meeting held on the 30 May 2019 were received, read and approved

Motion: To accept the minutes dated 30 May 2019 as a true and correct record of

that meeting - Moved by Michelle, seconded by Ruth, all in favour, carried.

Matters:

Matters arising from the minutes were discussed and noted below:

- 1. Ruth will update the Marae Committee Who's Who on the website so whānau know who is responsible and who has keys etc.
- 2. No money was received from Christine Tamati for the use of the marae for Wānanga
- 3. Whānau appreciate the use of the blue mattresses. Shona said this is going well.
- 4. The 29 June cleaning day did not take place as planned because the mattress inventory was already done by Shona.

Trustees Update:

Work with HB Prison

• Whareki reported on the hapū mahi that Ngāti Poporo are doing with the HB Prison. Michelle was able to table the documentation. Basically the purpose of the relationship between Ngāti Poporo and the HB Prison is to work together as a council in all matters relating to programmes for people in prison where they are less likely to reoffend. Kevin Tamati, Laura Kele and Tatiana will represent Korongata, while Donna Huata, Pare Morrell and Queenie Cooke represent Mangaroa Marae. Whareki will find out more info and keep us informed. Ruth will put this relationship up on the website under our community involvement.

Korongata Marae AGM

The Marae Committee asked if a date for the AGM has been sorted. Whareki will follow up with the Trustee Chairperson or Secretary to get feedback.

Bookings:

Ruth gave a report on the Bookings.

- There have not been many bookings. Those who have asked have paid a koha. Whānau have used Matariki for eating only which has been fine.
- A whānau had requested to use the marae ablution block. There was a misunderstanding where we thought it was for one night. After one week of using the ablution block the committee let the whānau know that there is a cost affiliated with the usage. The whānau member said they understand and did not reply. Although this was an opening to give the whānau an opportunity to give a koha, they clearly refused and have not been back.
- Ruth to update the marae committee, marae booking info and the who's who on the marae website.
- Susie Morrison whānau have asked to use the marae for their mums unveiling. There
 has been no other communication regarding date etc. Whareki will follow up with Edlan.

- There is an issue with the flooring in the kitchen. The Marae Committee approved to get this fixed. Michelle will contact a builder to fix the floor boards of the affected area in the kitchen.
- Shona reported that there is a need for a plumber as the new dishwasher is leaking.
 Michelle to get a hold of the Plumber to come and fix it immediately.

Communications Report:

Ruth gave an update.

- Oranga Marae have hui coming up. (Panui attached). Ruth to send this on to Alayna and
 ask who the Trustees are sending along to the meetings. Ruth also to ask Alayna for an
 update on the Marae status for a panui update.
- Alayna forwarded the Heretaunga Tamatea Settlement Trust Elections info. We read out Alaynas email of interest to stand. Basic timeframe Stage One 12 August Nominations Open, Stage Two 30 August 1pm Nominations Close, Stage Three If more than one nomination received, election hui needs to take place between 9 September-4 October. Stage Four 11 October Results Announced. Ruth to panul out to the whānau.

Financial Report:

Michelle gave a report on the Finances (See attached).

- Balance as of today is \$29,633,06. This does not include the term deposits which sit at \$20k x 3 separate terms.
- Tractor needs major repairs. Unbeknown to us, Edlan had an accident on the tractor in
 the early days which caused damage to the safety frame of the tractor. Lawrence has
 been using the tractor without the safety frame which is dangerous. The major repairs
 will cost \$2351.30. Payment was approved by the Committee. Michelle will pay for the
 mower today. Lawrence has been asked to get the weed eater and weed sprayer from
 Edlan. Ruth or Lawrence will follow up with Edlan.
- Motion: 'That we receive the finance report' Moved by Michelle, seconded by Whareki, all in favour, carried.

Chairman Report:

- Whareki thanked us for calling the meeting and said that we should meet when we need to, rather than planning a meeting just for the sake of meeting.
- Whareki mentioned the issue around the marae land and encroaching neighbours building further back into marae whenua. Paratene has been approached but asked if other neighbours will be approached with the same issue. This is a Trustee Committee issue.

MARAE ELECTORATE NOMINATION

First Schedule

2.3 Marae Electorate Nomination

Each applicant must select their Marae Electorate for the purpose of electing Trustees in accordance with paragraph 5 of the Second Schedule (of the Heretaunga Tamatea Settlement Trust – Deed of Trust). In selecting a Marae Electorate;

- a) where an applicant affiliates to only one Heretaunga Tamatea Marae that applicant may only select that corresponding Marae Electorate as his or her Marae Electorate;
- b) where an applicant affiliates to more than one Heretaunga Tamatea Marae the applicant may select only one corresponding Marae Electorate as his or her Marae Electorate; and
- c) an Adult Registered Member may change their Marae Electorate at any time except for during an Election Period or within twenty-four (24) months of having previously selected a Marae Electorate.

CANDIDATE NOMINATION

Second Schedule

1.1 Eligibility For Nomination:

To be elected as Trustee a nominee for appointment must:

- a) as at the closing date for nominations, be recorded in the Heretaunga Tamatea Register as an Adult Registered Member of Heretaunga Tamatea;
- b) and not:
 - i. be an undischarged bankrupt;
 - have ever been convicted of an offence involving dishonesty as defined in section 2(1) of the Crimes Act 1961, or an offence under section 373(4) of the Companies Act 1993 (unless that person is an eligible individual for the purposes of the Criminal Records (Clean Slate) Act 2004);
 - iii. be or have been disqualified from being a director of a company registered under the Companies Act 1955 or the Companies Act 1993;
 - iv. be or ever have been removed as a trustee of a trust by order of Court on the grounds of breach of trust, lack of competence or failure to carry out the duties of a trustee satisfactorily;
 - v. be physically or mentally incapacitated to the extent that he or she is unable to perform the duties of a Trustee;
 - vi. be subject to a property order made under section 30 or 31 of the Protection of Personal Property Rights Act 1988;
 - vii. have been convicted in the last 10 years of an offence punishable by more than three years imprisonment (unless that person is an eligible individual for the purposes of the Criminal Records (Clean Slate) Act 2004); or
 - viii. have been removed as a Trustee under paragraph 6.3 of this Schedule within the past three years.

VOTING

Second Schedule

5.2 Elections on the basis of Marae Electorates:

Every Adult Member may vote for a candidate nominated in their Marae Electorate. Every Adult Member may exercise only one (1) vote.

5.3 Candidates with most votes elected

The candidates in each election who receive the highest number of valid votes for the relevant vacancies will be elected as Trustees. If there is an equal number of votes for a relevant vacancy, then the successful candidate will be decided by the drawing of lots in a manner determined by the Chief Returning Officer.

5.4 No elections where a single nominee for a vacancy:

In the event that there is no more than one (1) valid nomination of a Trustee for a relevant vacancy no election shall be necessary and the person or persons nominated shall be deemed to have been duly appointed.

Fourth Schedule

2.1 Method of voting:

A voting process conducted in accordance with this Schedule must be conducted by postal vote to a physical, electronic, and/or digital address as determined by the Trustees from time to time.

2.2 Eligibility to vote:

Those eligible to vote in accordance with this Schedule are:

- a) those Adult Registered Members identified on Heretaunga Tamatea Register on the closing date for voting; and
- b) subject to clause 7.2 of this Schedule, any other Adult Member of Heretaunga Tamatea and has on or before the closing date for voting, provided to the Chief Returning Officer an application for registration as a Member of Heretaunga Tamatea which complies with paragraph 2 of the First Schedule to this Deed.
