5.0 Marae Trustee Chair Report – Alayna Watene: Tabled and read.

Schedule of Meetings – Tabled and read by A Watene:

- Dates for Trustee hui were set for the first Fridays of each month all agreed;
- Each Marae Trustee hui had 30 days notice to inform Trustees and to allow apologies to be tendered before the scheduled meeting dates;
- Hui dates were changed to the last Friday of each month still not quorum at these hui;
- 10 Trustees to present at Marae AGM 22 September 2018. Quorum was set to 5. Confirmed by Maori Land Court records (via submitted AGM minutes).
- NB: Monthly hui held./scheduled but no quorum at majority of hui. This
 negatively impacts decision making as a Trustee Board.

Marae Committee Re-Structure – Tabled and read by A Watene:

- A mihi was extended to the Marae Trustees who did consistently attend hui and to the Marae Committee for their mahi and upkeep of operational functioning of the marae.
- Marae Trustees wil do their best to support and encourage Trustees, Marae Committee and whanau toward future plans of the marae.

A Watene responded in the report that this is to be addressed with the Marae Trustees. However due to nil quorum at the Trustee meetings, the matter has not been fully discussed to date but will be tabled and re-visited again in the near future.
